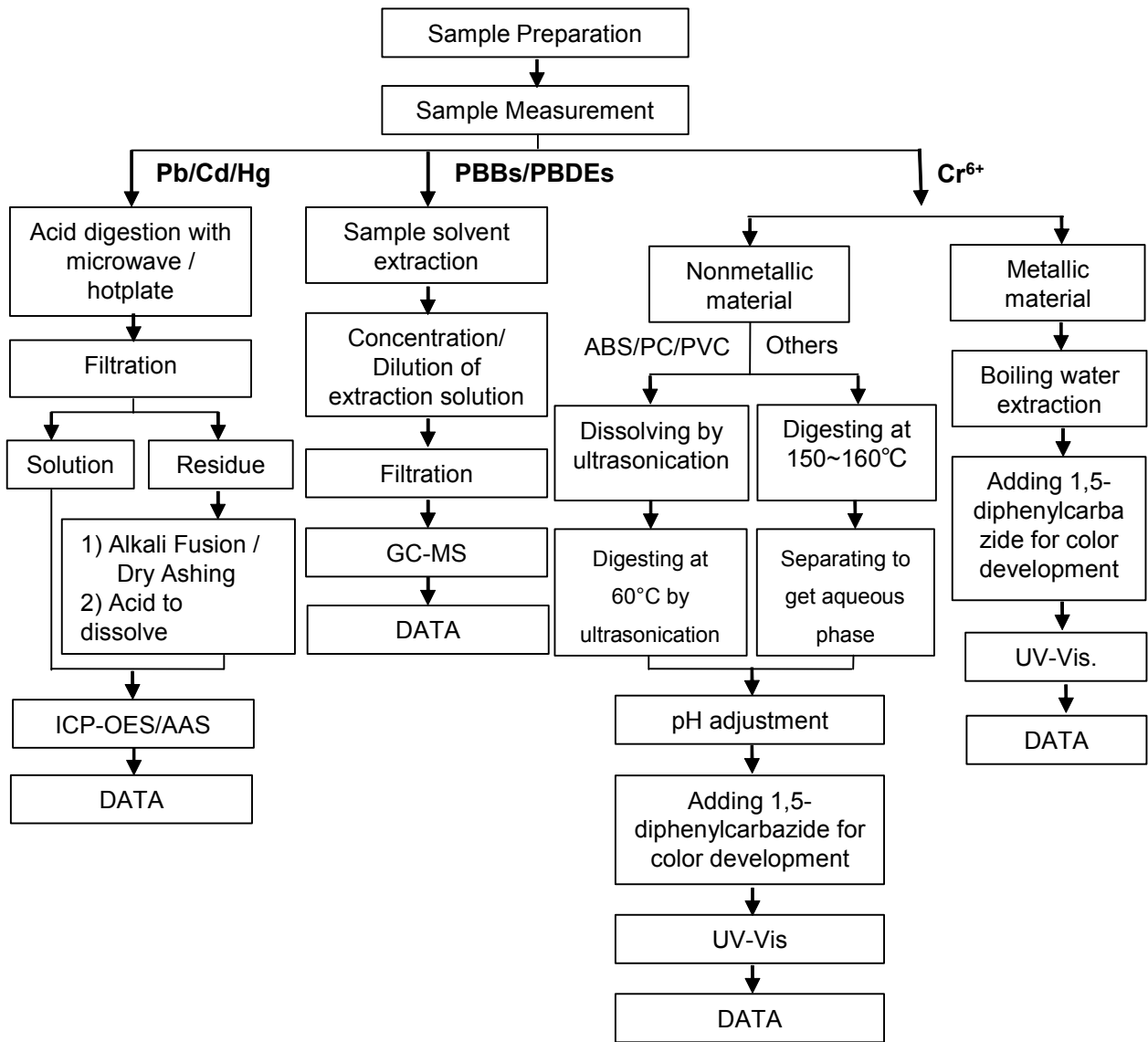

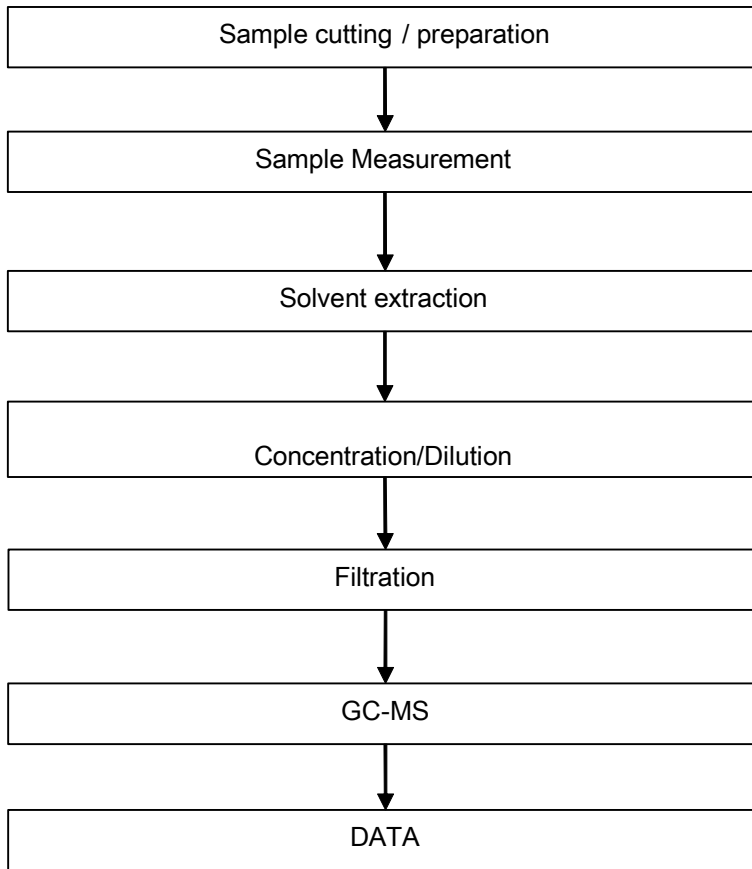

Phthalates Testing Flow Chart

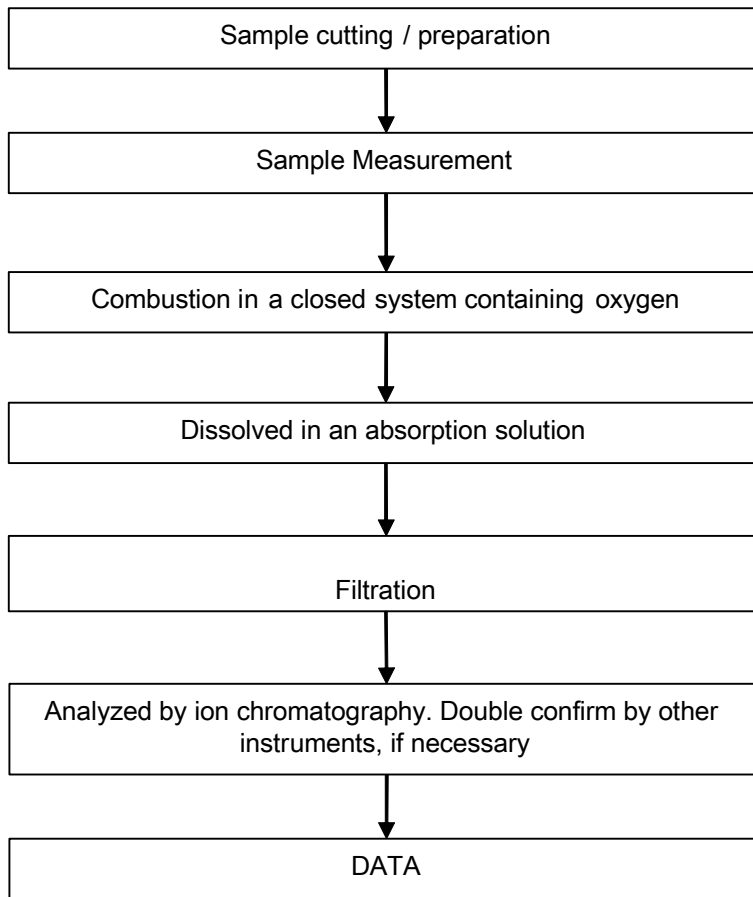

Halogen Testing Flow Chart

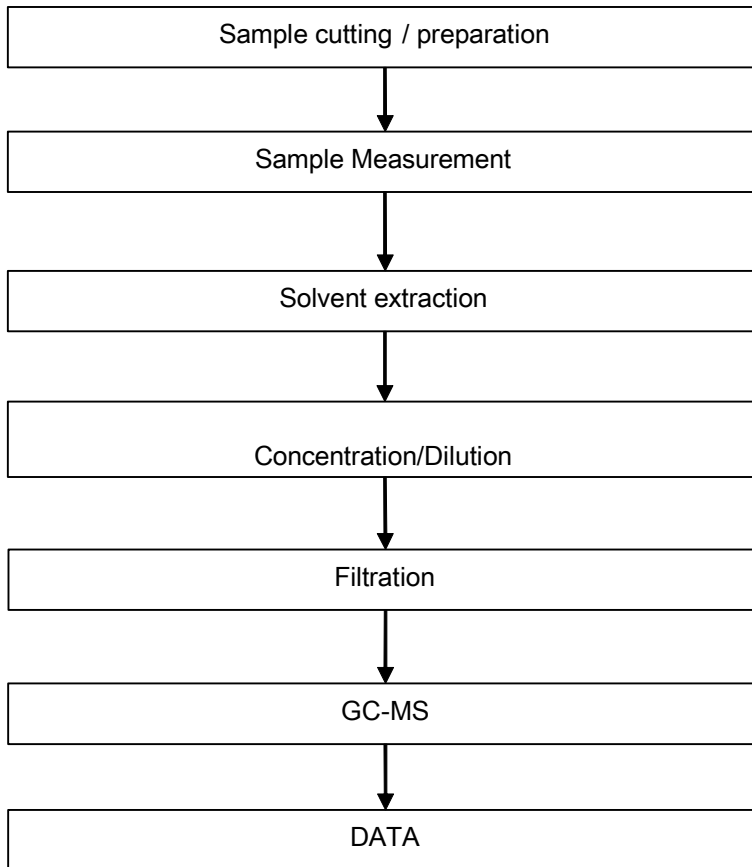

HBCDD Testing Flow Chart

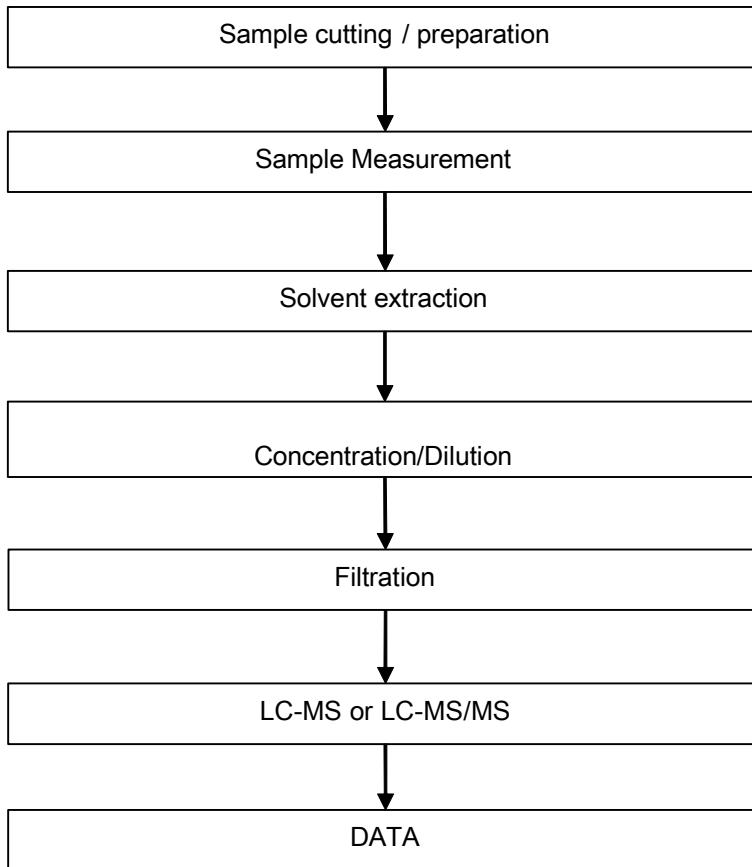

PFOA / PFOS Testing Flow Chart

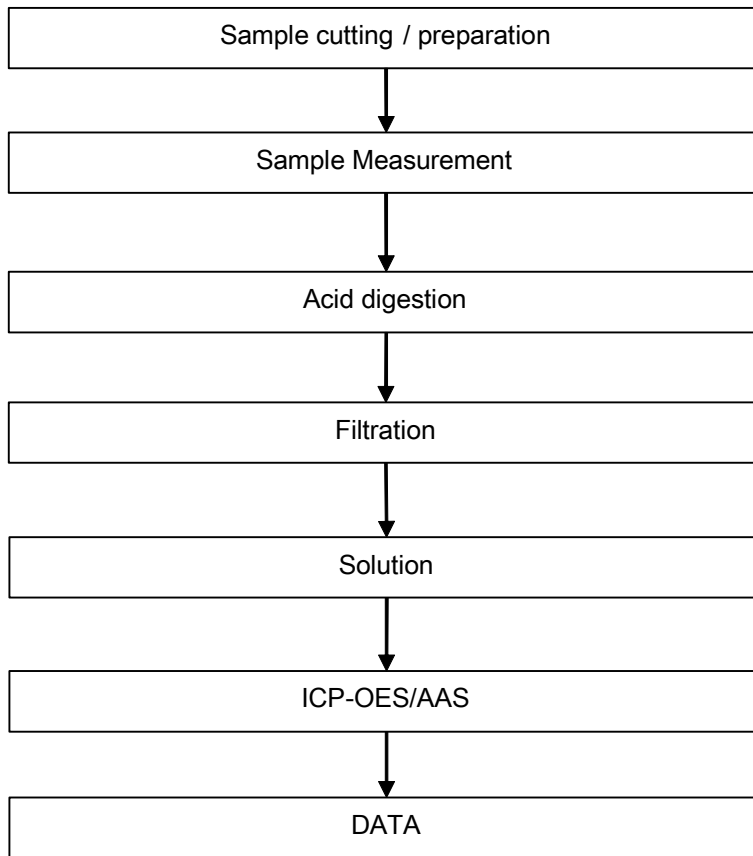

Elementary Testing Flow Chart

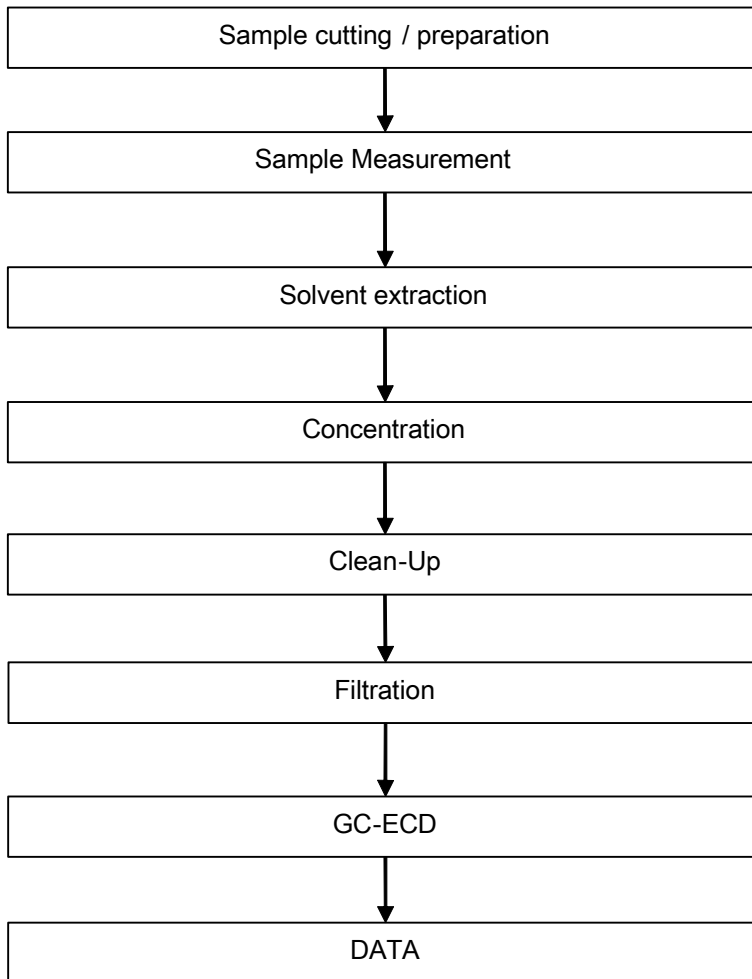

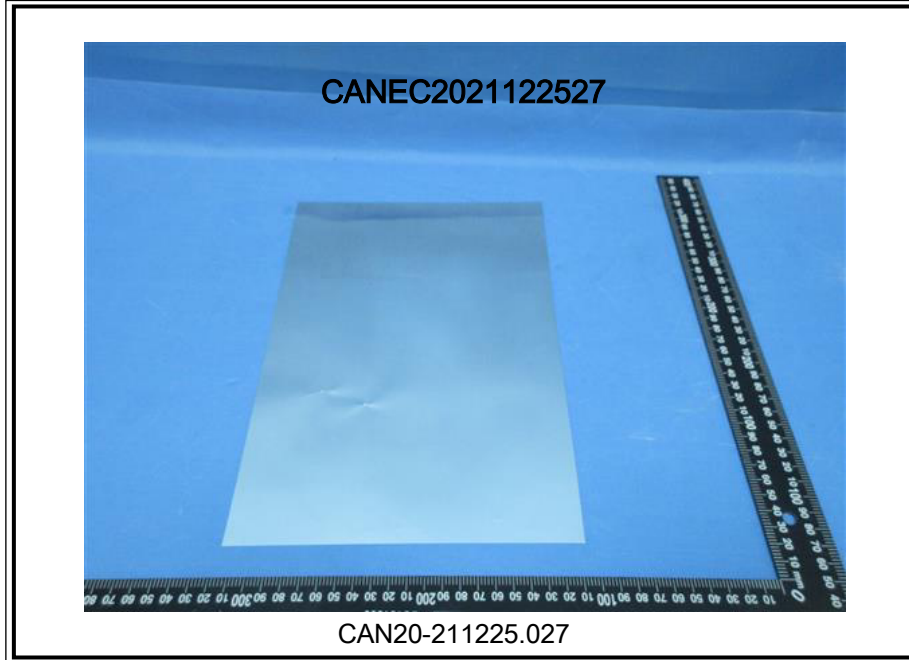
SCCP/MCCP/LCCP Testing Flow Chart
